Organizational Fund: This fund is established by public charities and offers them a simple and efficient way to build endowment and create sustainability. The Community Foundation helps the organization with planning, investing and administering the funds, as well as distributes grant dollars to the organization for general purposes.

Unrestricted Funds: The donor allows The Community Foundation to use available grant dollars for a broad range of community issues. This allows the foundation to respond to changing community needs over time.

No director shall vote on any matter in which he or she has a material and direct financial interest that will be affected by the outcome of the vote. In the event of such an abstention, the abstaining director shall state the reason for the abstention, which shall be noted in the minutes of the Board of Directors. In addition, the abstaining director shall not participate in discussions about the matter other than to respond to questions for information that may be relevant to the discussion, and if not needed for that purpose will leave the vicinity so as not to be present during the discussion.

In connection with any actual or possible conflicts of interest, an interested director or interested officer must disclose the existence and nature of his or her material financial interest to the board prior to the consideration of the proposed transaction, contract, or arrangement by the board or any committee of the board. After disclosure of the financial interest, the disinterested members of the board shall determine whether a conflict of interest exists. Neither the board nor any committee of the board shall vote upon any proposed transaction, contract, or arrangement in connection with which an actual or possible conflict of interest has been disclosed by an interested director until such time as the board has addressed the actual or possible conflict of interest.

Where the board has concluded that a conflict of interest exists, the chairman of the board or committee of the board shall, if appropriate, appoint a disinterested person or committee to investigate alternatives to

the proposed transaction, contract, or arrangement. After exercising due diligence, the board or committee shall determine whether the foundation can obtain a more advantageous transaction, contract, or arrangement with reasonable efforts from a person or entity that would not give rise to a conflict of interest. If a more advantageous transaction, contract, or other arrangement is not reasonably attainable under circumstances that would not give rise to a conflict of interest, the board or committee shall determine by a majority vote of the disinterested directors whether the transaction, contract, or arrangement is in the foundation's best interest and for its own benefit and whether it is fair and reasonable to the foundation, and shall make its decision as to whether to enter into the transaction, contract, or arrangement in conformity with such determination.
